#### Vera Institute of Justice Launches ICON (Immigrant Connection Project)

ICON, a partnership between the Vera Institute of Justice and New America, is a resource for parents who have been separated from their children due to the administration's zero tolerance policy - as well as for the attorneys for these parents - to locate and connect with the legal service providers working with their children. ICON also seeks to ensure due process for these separated children and their families. While the federal government is the only entity that can physically reunite children and families, ICON provides a route to connect parents and their legal representatives with a legal service provider that is working directly with their children. #### Bolder Advocacy: 501(c)(3)s Have a Role to Play in Getting Out the Vote

It's important to know that 501(c)(3)s can and should play an important role in getting people to the polls when critical issues are at stake. Although 501(c)(3)s cannot tell people who to support or vote for, they can encourage people to go out and vote. They can even conduct voter registration drives. Before doing so, it's a good idea to check your state's voter registration laws. It's important to understand deadlines, how to handle the registration forms, and other practical details that will dictate how you conduct the drive. Read more.

#### **Praxis International: Make The Call Toolkit**

Implementing an advocacy-initiated response (AIR) can provide critical information about upcoming court processes, resources available to help with court proceedings, and support available for coping

with other aspects of life affected by a batterer's behavior. The Make the Call Toolkit offers a free, ondemand resource for advocacy programs to explore, adapt, and implement the AIR model to connect victims of battering with community-based advocacy as soon as possible after law enforcement has responded to a domestic violence 911 call. <u>Click here</u> to access this toolkit.

- Provide a listing of services available for Al/AN survivors of crime and abuse
- Help identify and address gaps in services

The Tribal Resource Tool is an innovative collaboration between the <u>Office for Victims of Crime</u>, the <u>National Congress of American Indians</u>, the <u>Tribal Law and Policy Institute</u>, and the <u>National Center for Victims of Crime</u> with the input and guidance of <u>tribal stakeholders</u> across the country.

#### Minnesota Office of Justice Programs: Nevada Route 91 Shooting Victim Outreach - Reparations for Minnesotans

There were 101 tickets sold in Minnesota to the Route 91 Harvest Festival in Las Vegas, Nevada, where the tragic mass shooting occurred on October 1, 2017. As of June 2018, the Nevada Victims of Crime Program (similar to the Minnesota Reparations Board) has received only 11 assistance applications from Minnesota survivors. If you know anyone who was present at the Route 91 Harvest Festival shooting, please encourage them to visit <a href="VegasStrongRC.org">VegasStrongRC.org</a> and apply for reparations, as the deadline for accessing potential financial assistance is October 1, 2018.

Funds from the program may help reimburse survivors for out-of-pocket expenses resulting from the crime such as medical bills or counseling co-pays not covered by insurance. Even if survivors don't have any eligible expenses now, survivors are encouraged to apply for the program before the deadline in case they incur future expenses that may be covered by the program.

The Vegas Strong Resiliency Center serves as a free, one-stop resource and referral hub for anyone affected including survivors, family members of victims, responders, and anyone dealing with effects from the attack including hotel workers, taxi cab drivers, or bystanders who tried to help victims. Since the Resiliency Center opened, it has served more than 6,000 people. Services include victim advocacy and support, grief counseling and spiritual care referrals, and technical assistance accessing online resources including FBI Victim Assistance Services for claiming personal items left behind at the October 1 concert venue.

#### **About This Webinar:**

Reproductive coercion is any behavior(s) intended to maintain power and control over an individual's reproductive decisions and health, such as monitoring menstrual cycles or destroying someone's contraceptives. It often occurs in an intimate partner context, making it a devastating and often unrecognized form of domestic abuse that until 2013 was not officially recognized by the American College of Obstetricians and Gynecologists.

This webinar will cover the three main forms of reproductive coercion: birth control sabotage, pregnancy pressure/coercion, and sexual coercion, with detailed case studies to represent each form, in addition to information about assessment and safety planning, harm reduction strategies, legal remedies, and legislation. The focus of the presentation is to provide basic introductory information

about an under-studied form of domestic abuse, and will be particularly useful for victim/witness advocates, social service providers, prosecutors, and law enforcement.

#### **About Meggie Royer**

Meggie Royer is the Education and Outreach Coordinator at Women's Advocates in St. Paul, the nation's first domestic violence shelter. She provides trainings to social service providers, healthcare providers, students, criminal justice professionals, and more, covering topics such as revenge pornography, domestic violence, healthy relationships, strangulation, and the pregnancy-homicide link. She most recently presented on reproductive coercion at the Office of Justice Programs' Conference on Crime and Victimization in May 2018.
