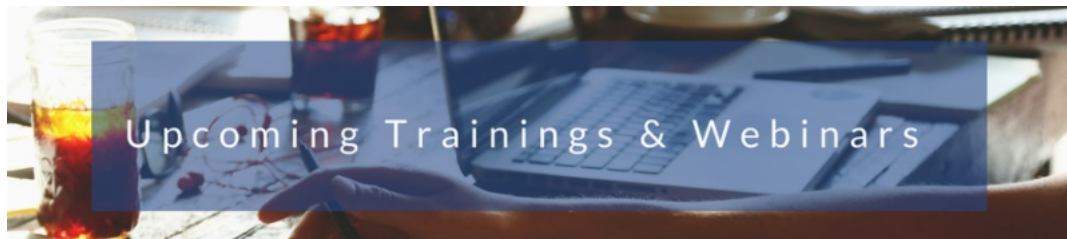

### **WATCH: Addressing the Demand Side of Sex Trafficking Report**

WATCH launched its Sex Trafficking Initiative in January 2014. This report focuses specifically on buyers of sex in Hennepin and Ramsey County. The key findings in this report are derived from information collected from 136 cases involving Minnesota Statute 609.324. These 136 cases involve both underage and adult victims of sex trafficking. In this report the key findings and recommendations apply to cases of purchasing sex with underage girls. [Click here.](#)

#### About This Event:

We are excited for you to join us for the July meeting of the Minnesota Identity Theft & Cybercrime Information & Resource Network (MITCIRN). The first half of the day will consist of a network meeting to discuss network business as well as opportunities for connecting with other participants, as well as time for committees to meet to discuss committee goals and work in person.

In the afternoon, there will be advanced training. The advanced training is still in the process of being confirmed. Currently we are anticipating:

- Jen Fox, Director of Consumer Outreach and Community Relations, Department of Commerce, who will speak about the work happening at the Department of Commerce, including investigations that happen within the department, and will share resources.
- Assistant U.S. Attorney Tim Rank, Criminal Division: Fraud and Public Corruption Section, U.S. Attorney's Office, presenting on the Electronic Communications Privacy Act (18 U.S.C. §2510) & Computer Fraud and Abuse Act (18 U.S.C. §1030).
- Pauline Sager (Investigative Aide, Eden Prairie Police Department) and Susan Krum (Senior Assistant County Attorney, Hennepin County), who will discuss how they created the *Hennepin County Identity Theft Resource Guide* for victims, and will provide insights as to how other counties can do similar work to reduce the work victims have to do when reporting to law enforcement about identity theft.
- Cybercrime Panel, featuring Christophe Veltsos, CISSP, CISA, CIPP, Professor at Mankato State University

### **Caught and Rescued: Case Study Identifying, Investigating, and Prosecuting Human Traffickers**

You will learn actions to take once a victim has been identified, ways to partner with the victim and witnesses, important investigation tools, and tips to work hand in hand with the prosecuting attorney to win your case. ### **“You Can’t Believe a Word She Says!”: Credibility Issues for Survivors of Violence with Mental Health and Substance Abuse Histories**

Survivors who experience mental health or substance use conditions may not be believed when they seek help. These survivors may be experiencing the mental health effects of trauma and/or using substances to cope. In addition, individuals who have a preexisting condition are at a higher risk for violence and may even be targeted for abuse precisely because they are less likely to be believed. Abusers may also intentionally exacerbate a preexisting condition or coerce or force their partners into using alcohol or drugs. But many survivors with these experiences are discredited when they access our systems. This webinar will explore these dynamics and consider how we can reframe the way that we think about survivors’ credibility. [Learn more.](#)

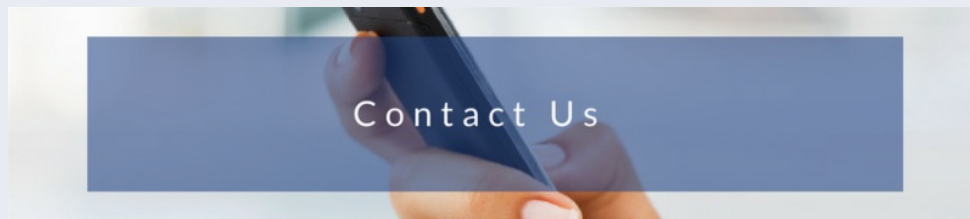
