

Dream Corps: Survey on Fines, Fees, and Restitution

The average person leaving prison returns home with \$13,000 owed in either fines, fees, or restitution. It is a huge financial burden, which can make reentry even more challenging than it already is. More often than not, low-income communities of color are the ones who are paying these expenses, and many of them struggle to do so. **Do you or a loved one currently owe any fines, fees, or restitution as a result of incarceration?** Dream Corps #cut50 is partnering with the **Fines and Fees Justice Center** to tackle how COVID has impacted people who owe any type of fines, fees, or restitution. We've put together a survey with questions surrounding how the pandemic has impacted a person's inability to pay their state owed debt. The responses will help both #cut50 and our partner, Fines and Fees Justice Center, identify the challenges COVID has had on those who owe fines and fees and what long-term changes we can advocate to make this system work for everyone. National Center for Victims of Crime: Promising Practices - Multidisciplinary Responses to Complex Homicide Cases Report

The Promising Practices report includes information provided by demonstration sites and subject matter experts on improving responses to homicide cases. COVID-19 has forced victim service providers to adapt and change to new ways of creating access for

their clients. Advocates play an important role in creating greater access for survivors who are limited English proficient or Deaf and Hard of Hearing to other community systems and resources. This work is critical in order to decrease barriers for survivors, makes approaching the same resource easier the next time, and decreases barriers for others in similar situations. This prerecorded session provides practical information on how to prepare advocates to facilitate change by intervening when systems are not complying with laws and guidelines regarding language access provision.

Propel Nonprofits: Seeking Proposals for COVID-19 Recovery Grants

Propel Nonprofits is seeking proposals for COVID-19 recovery grants for nonprofits. Nonprofits and fiscally sponsored organizations invited to apply are those led by Black, Indigenous, and People of Color (BIPOC) and serving BIPOC communities, with an organizational budget size between \$100,000 and \$2 million, and that has been in operation a minimum of one year. Grants awarded will be general operating funds. These grants are intended to support nonprofits in their response to and recovery from the effects of the COVID-19 pandemic, including resulting financial impacts on operations and effects on communities served.
