Olga Trujillo is an attorney, speaker, author and survivor. Olga graduated from the University of Maryland in 1983 with a Bachelor's Degree in Political Science and graduated from George Washington University's National Law Center in 1988 with a Juris Doctor Degree.

Her experience over the past 27 years has been as a private attorney; an attorney for the U.S. Department of Justice; a consultant to many local, state and national organizations on issues of domestic violence, child welfare, sexual assault, trauma and immigration issues; and a nationally sought speaker and author.

Her memoir for New Harbinger Publications entitled "*The Sum of My Parts*" was released in October 2011.

Olga will discuss her personal journey with physical and sexual violence, understanding Dissociative Identity Disorder, and will explore trauma and dissociation and what this means for your work with victims of domestic violence.

Jessica herself has faced many challenges in life but none as daunting as losing her three daughters Amara, Sophie, and Cecilia to domestic violence in July of 2012. Her journey from victim to survivor has been borne upon a river of support from her family, friends, and community. Jessica has embraced a philosophy of choosing light over darkness and strives to use her grief as fuel to make the world a better place.

She was blessed by a vast array of community groups, businesses, and individuals who came together to build an all-inclusive playground in River Falls, WI in honor of Amara, Sophie, and Cecilia. She is currently employed by Washington County Community Services as an Adult Protection Investigator. Jessica resides in River Falls, WI with her husband Matthew, stepdaughters Ellianna and Maya, and her children Trinity and Flint.
