During Fiscal Year 2017, our staff grew to 2.5 FTE, MAC added 19 new member programs (bringing us to a total of 68 members), and we completed development of and deliver the Fundamentals in Victim Services training. have begun to

manifesting our mission


In FY2017, MAC prioritized building our capacity to better meet the needs of our members and to ensure governance best practices.

- MAC obtained increased funding to add 1.5 FTE staff—the training and engagement coordinator and the administrative and volunteer coordinator.
- MAC Board of Directors committees began to meet regularly to ensure best practice compliance in all areas of governance.
- The Board developed new bylaw articles to ensure best practice recruitment practices and thorough vetting of candidates.
- The Board reviewed all organizational policies and bylaws.
- The executive director developed and the Board approved a financial guidelines manual.
- MAC staff received performance reviews consistent with bylaws.
- MAC developed a comprehensive five-year strategic plan to guide our work.

developing & increasing MAC membership

In FY17, the MAC board and staff engaged in intentional work to grow and diversify our membership so it is more reflective of crime victims throughout Minnesota.

- During the year, MAC's membership grew from 49 to 68 programs, an increase of 39%.
- MAC staff participated in diverse collaborative working groups to build relationships with allies and stakeholders.
- MAC made intentional outreach to traditionally underserved groups of crime victims to ensure their voices are elevated.
- Increased membership benefits provided the opportunity for members to build their capacity to meet the needs of all crime victims.

developing & sustaining core programs

With additional funding, MAC was able to grow our core programming in FY17.

- MAC formed the Public Policy Committee, which met weekly throughout the 2017 legislative session.
- Members utilized the members listsery to connect with each other and get quick responses to questions.
- The monthly newsletter reached more than 600 professionals in the field.
- MAC more than tripled the number of in-person and webinar trainings it offered.
- Staff provided approximately 150 hours of technical assistance to member programs.
- MAC provided training to 689 individuals statewide.
- The Capacity Building Training in September 2016 offered in-depth training to more than 65 members.

In June 2017, MAC launched Fundamentals in Victim

Services, a two-day training for new general crime advocates that covers bias, privilege and oppression; core advocacy, systems advocacy, victims' rights, and more. The training included 50 participants from agencies all over Minnesota. MAC will offer Fundamentals in Victim Services again in 2018.

engaging stakeholders

MAC is making progress towards fulfilling our mission with the support of stakeholders and allied partners.

- MAC meets regularly with other statewide criminal justice stakeholders to identify and discuss emerging issues affecting crime victims.
- MAC meets monthly with other state crime victims' coalition directors to ensure they inform and support our work.
- MAC has increased our exposure to the stakeholders and the general public through our monthly newsletter and social media.

In FY17 MAC was successful in advocating with state funders

for additional funding opportunities for general crime victim services throughout Minnesota and funding for a Twin Cities metro-based direct service general crime program.

As a result of this advocacy, in January 2017 the Cornerstone Day One Center launched the Minnesota Crime Victim Hotline. In July 2017, Cornerstone opened the General Crime Victim Services program in Minneapolis, which serves general crime victims throughout the Twin Cities metro area. MAC has been working with Cornerstone to ensure that the staff of these new programs receive the training they need to assist general crime victims.
