Office for Victims of Crime: Funding Announcement - Grants to Support Housing Assistance for Victims of Human Trafficking

The U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), Office for Victims of Crime (OVC) is seeking applications to support housing assistance for victims of all forms of human trafficking throughout the United States. This program furthers DOJ's mission by enhancing the field's response to victims of human trafficking. Applicants must register with Grants.gov prior to submitting an application. All applications are due by 11:59 p.m. (eastern) on Monday, February 3, 2020. **Learn more**.

National Human Trafficking Training and Technical Assistance Center: New Online Module SOAR for Native Communities

The SOAR for Native Communities online module helps those serving indigenous populations to better understand human trafficking and its impact on Native communities. The training includes resources relevant to indigenous populations and supports professionals in building trauma-informed and culturally responsive interventions to human trafficking in American Indian, Alaska Native, Native Hawaiian, and Pacific Islander communities. **Learn more**.

National Institute of Justice Study: Batterer Intervention Programs Have Mixed Results

Courts often mandate that convicted abusive partners attend batterer intervention programs in addition to serving a probation term. NIJ-funded researchers have evaluated the most common batterer intervention programs. A number of batterer program evaluations have been conducted, but with inconsistent results. There are a number of interventions that are common in the treatment of domestic violence offenders. Meta-analyses of two prominent approaches — the Duluth model and cognitive behavioral therapy — have been reviewed and rated under NIJ's CrimeSolutions.gov process. Read more.
