


Please Welcome MAC's Newest Staff Member: Amee Krogfus

Minneapolis Star Tribune: Denied Justice Final Installment - When Rape Is Reported in Minnesota and Something Happens

In 2008 the Star Tribune began documenting chronic errors and widespread failings in the way Minnesota police, prosecutors, and judges handle rape cases. The reports, along with video testimony of dozens of women, galvanized victims of sexual violence, lawmakers, and law enforcement officials alike. The 2019 Legislature will consider sweeping measures to fix “systemic failures” identified by a state task force in the way the criminal justice system handles sex assault cases. The board that licenses all police officers is recommending new specialized training and clear investigative protocols, and local police departments and county attorneys are dedicating more staff and other resources to sex assault cases. National Latin@ Network: Emergency Preparedness from an Intersectional Approach

Disasters, whether man-made or natural, affect entire communities regardless of an individual's age, immigration status, ability, faith practices, racial and/or ethnic identity, or gender identity. Current research on emergency preparedness systems consistently demonstrate minority communities are more vulnerable than others across the range of events before and after a disaster. Minneapolis Star Tribune: Minnesota Attorney General's Task Force Sends Rape Investigation Recommendations to Lawmakers


A state task force appointed to rectify "systemic failures" in the way Minnesota law enforcement agencies handle sex assault cases issued a wide ranging set of policy recommendations on Tuesday ahead of the 2019 legislative session. The panel called for legislation that would require police agencies to adopt clear protocols on sexual assault cases, improve officer training and collect better data on such investigations. The Legislature should also consider creating a statewide council focused on sex assault investigations and set aside money for "innovation grants" for agencies, the report added. Safewise: The Safest and Most Dangerous States

While all states have drunk drivers, some have more than others. Safewise identified the states where you're most likely to run into drunk driving danger—and the ones where the roads should be safer. To find the most dangerous states, we looked at the most recent data for impaired driving deaths from the National Highway Traffic Safety Administration. **Interestingly, Minnesota ranked #3 for the fewest impaired driving deaths while our next door neighbor North Dakota ranked #3 for the most deaths.** [Read more.](#)

Women's Advocates: Racism Compounds Domestic Violence Against Black Women. Acknowledging This Is Not the Same As Denying Violence Against White Women

A powerful blog post by Meggie Royer of Women's Advocates in St. Paul: On November 17, 2018, Aisha Fraser, a beloved elementary school teacher in Ohio, was stabbed to death by her abusive ex-husband. On November 19, 2018, Dr. Tamara O'Neal, a critical care specialist at a hospital in Chicago, was shot to death by her former fiancé. Both Aisha Fraser and Dr. Tamara O'Neal were black women. And like many black women, both of them, in life and in death, experienced the catastrophic impact of public stigma against domestic violence, painstakingly multiplied by racism and inequity. The Department of Public Safety Office of Justice Programs is seeking presenters for its **31st Annual Conference on Crime and Victimization**. This multi-disciplinary conference attracts victim advocates, criminal justice professionals, researchers, medical responders, educators, and others, with topics that span the wide range of crime victimization and issues related to responding to crime victims.

Workshop proposals are especially being sought for:

- Models of collaboration to strengthen efforts to serve victims and survivors of crime.
- Multidisciplinary approaches to investigate and prosecute specific types of crime.
- Promising/best practices in crime victim response, investigation, prosecution, and post-conviction.
- Challenges, strategies, and best practices for reaching and serving traditionally underserved populations.
- Emerging research on improving the response to crime and victimization.
- Increasing organizational capacity for nonprofit management and executive level leaders.

Barb Hedstrom, from the Shakopee Police Department, was honored in October 2018 with the International Association of Chiefs of Police Leadership Award. Below is an article about Barb's innovative work from the IACP's [Police Chief Magazine](#). Congratulations to Barb!

An organization's self-evaluation often reveals both hidden strengths and hidden weakness. For Shakopee Police Department, a small agency in Minnesota, one of the latter was victim services. Their solution? Adding a victim services coordinator to the agency's staff.

The victim services coordinator provides trauma-informed support to crime victims by assisting in the investigation stage of a case, educating crime victims on their rights and the criminal justice system, and helping victims to access resources available to them. The coordinator also supports the officers and investigators, who are often the first line of victim contact and services. Barb Hedstrom at the Shakopee Police Department says that her role "is to help [officers] do their job while bringing a victim-centered, trauma-informed atmosphere" to the agency.

Ms. Hedstrom's position is two-fold: as a victim and a community services coordinator. In addition to victim services, she represents the police department in the community through activities ranging from working with the local diversity organization to organizing volunteers to paint over graffiti.

Sometimes the number of people killed in an intimate partner homicide event reaches four or more, making it a mass murder. 
