Pernicious

Definition

per·ni·cious /pərˈniSHəs/ adjective

having a harmful effect, especially in a gradual or subtle way.

"the pernicious impact of not being victim centered"

Coming to the CVJU's attention

Prosecutor based advocates

- Being clear about limits of confidentiality
- Facilitating communication with the prosecutor ("why can't I talk with the prosecutor?")
- Victim notification: When mail has to travel long distances before getting delivered – time to rethink our process

Coming to the CVJU's attention

Community based advocates

- Data, data, data
 - Getting police reports
 - LEO inquiries to shelters
- Role in post-conviction
- Narrow definition of "advocacy"

Coming to the CVJU's attention

In general

- City prosecutors
- Billing for sexual assault exams
- Setting realistic expectations on investigation, communication,
- charging, length of process, ability to speak with prosecutor, etc.

Minnesota Crime Victim Survey

- 37% of all Minnesotan's experienced some type victimization in 2016
- Property crime most common
- Person crimes reported at a higher rate
- About a third of all crime reported to the police
