# From MAC's Executive Director

Dear MAC Members and Allies:

*We need to give each other space so that we may both give and receive such beautiful things as ideas, openness, dignity, joy, healing, and inclusion.*

*Max de Pree (1924–2017)*



I love the above quote because it speaks to the 2018 National Crime Victims' Rights Week theme: *Expand the Circle: Reach All Victims*. MAC is committed to supporting our members in their efforts to remove barriers and ensure inclusion, acceptance, and informed services for ALL victims. If your crime victim service program is to achieve measurable goals, an intentional focus on forging meaningful partnerships has to be at the center of your work.

The power of partnerships launched the crime victims' rights movement and the achievements we celebrate every year. Families of murdered children and victims of sexual assault, drunk driving, domestic violence, and other crimes mobilized at the grassroots level, joining forces to demand justice for victims of crime. The National Campaign for Victims' Rights, founded by these partners, led to President Ronald Reagan's reforms on behalf of crime victims, his declaration of the first National Crime Victims' Rights Week, and the creation of the Victims of Crime Act and Crime Victims Fund, whose anniversary we celebrate during NCVRW each year in April. Through our partnerships and community building, we have made significant progress.

Borrowing from the [2018 NCVRW Resource Guide](#), here are some actions you can engage year round in to expand your organization's circle through partnership:

**Expand your network**—Partnering with organizations that work with specific communities is an opportunity to understand the barriers faced by victims, implement trauma-informed practices, and increase the cultural responsiveness of your organization.

**Build a multidisciplinary response team**—Multidisciplinary response teams often focus on victims of a particular type of crime, such as victims of sexual assault, victims with disabilities, or victims of child abuse. These teams can include, but are not limited to, cooperative responses to emergency calls, meetings between partners to discuss recent cases, and joint decisions in the interests of victims/survivors.

**Provide education about victims' rights and options**—[National Crime Victims' Rights Week](#) is a prime opportunity to educate your local community about the rights of crime victims. Hosting an information fair, fundraiser, school assembly, or other community event is a great way to build partnerships, increase the visibility of local victim service providers, and support greater understanding of victims' rights and options following a crime.

**Raise awareness**—Local community centers and businesses often have space to hang posters, collect donation items, and host events. These partnerships are important to developing lasting community engagement.

**Engage the media**—Work with your local newspaper, radio station, or TV news to tell the story of the good work your organization is doing on behalf of crime victims in your community.

This year, instead of shining a light on crime victims for a week during NCVRW, use the week as a launching pad to a year-long commitment to expanding your circle through both seeking and providing opportunities to increase partnerships in your work. As always, MAC is here to support your efforts in any way we can.



### About Rachael Joseph:

Rachael Joseph got involved in the victims' rights and gun reform movements after her aunt, Shelley Joseph-Kordell, was murdered in the courthouse shooting at the Hennepin County Government Center in September 29, 2003. Rachael is the co-founder and executive director of Survivors Lead, a 100% survivor-led organization that takes a municipal approach to reducing violence in low-wealth communities and communities of color. They also provide law enforcement consultations to reduce police violence and political trainings instructed through a trauma informed lens for survivors of gun violence, sexual and domestic violence interested in running for public office. Rachael serves on the Board of Directors of the Minnesota Alliance on Crime, is the former director of outreach and communications at Protect MN, and a former survivor engagement lead at Mayors Against Illegal Guns/Everytown for Gun Safety.

We are excited for you to join us for the official launch of the Minnesota Identity Theft & Cybercrime Information & Resource Network (MITCIRN).

The first half of the day will be the official first meeting of the network, featuring a welcome from former Minnesota Attorney General of the State and State Senator Skip Humphrey. Participants will learn more about MITCIRN, select a committee to engage in targeted efforts to strengthen victim support in Minnesota, and network with other attendees.

In the afternoon, there will be advanced training on often-neglected forms of identity theft (criminal, medical, child, and military identity theft), as well as training geared towards law enforcement, prosecutors, community outreach, and victim advocacy.


