Gathering & Preserving Technological Evidence

About the Webinar: The session will cover how electronics and the internet can be used to stalk or harass crime victims. Many are not aware of the extent to which technology can be used to track someone. For example, there are methods to track every single activity and movement of your cellphone without you even knowing it is happening. The objective of the webinar is to make these capabilities known so that advocates can better assist victims with protecting themselves from cyberstalking.

About the Presenter: Jeremy Roberts has been working in law enforcement for thirteen years, with the last eight years working in internet crimes and computer forensics. He originally hails from Georgia and served as a sheriff captain in metro Atlanta. While in Georgia, Jeremy worked with the Internet Crimes Against Children Task Force and assisted the U.S. Secret Service and Federal Bureau of Investigation on numerous cases. Along with over 1,700 hours of specialized law enforcement training, he also holds several computer forensics and ethical hacking certifications. Jeremy joined the Dakota County Sheriff's Office in March of 2015 to work with the Dakota County Electronic Crimes Task Force, where he is currently a digital forensics examiner.

Funding Alert: The Enhancement or Expansion of Existing Specified Domestic Violence Services or Sex Trafficking and Commercial Sexual Exploitation Services

In December 2016, the City of Minneapolis approved one-time only funding for the enhancement or expansion of specified existing domestic violence services or sex trafficking and commercial sexual exploitation services for agencies providing services within the City of Minneapolis.

The purpose of the funding for existing domestic violence programs is to expand or enhance services with a specific focus on serving families with young children ages 0-3, adolescent males, and families whose primary language is not English. The focus of the funding for existing sex trafficking and commercial sexual exploitation programs is specific to serving victims who are transgender, American Indian, or are young women and girls. Funding for new programs will be considered as part of an enhancement or expansion of a program as it relates to the implementation of services and not planning for new services. Applicants must be ready to start providing services at the start of contracts. [Click here for the RFP](#). **Proposals due February 15, 2017.**

Changing Minds About Children's Exposure to Violence

In October 2016, the Department of Justice (DOJ) launched Changing Minds, a national public education campaign to raise awareness, teach skills, and prompt public action in response to children's exposure to violence in the U.S. This multiyear campaign, established through DOJ's Defending Childhood Initiative, features digital and print content intended to reach adults who interact with children and youth in grades K–12. Day One Crisis Line Opens New Call Center for Minnesota Victims

[Cornerstone Advocacy Services](#) began operating the Day One Call Center on January 3, 2017. The call center is staffed **24 hours a day, 7 days a week**, with highly trained advocates who respond to crisis calls from two separate toll free numbers. The Day One Crisis Line responds to calls from victims of domestic violence, sexual violence, and human trafficking and the Minnesota Crime Victim Support Line responds to calls from general crime victims. Both toll-free numbers accept calls from across Minnesota. The Day One Call Center is focused on providing trauma-informed support, as well as immediate access to resources within the caller's identified community.

Process:

General crime victims, as well as survivors of domestic violence, sexual violence, and human trafficking, call just one number and are immediately connected to a crisis advocate who assesses the caller's needs and connects them with the most appropriate resource or service provider based on the caller's presenting issue and location. The advocate also takes into account any cultural and/or accessibility considerations. Telephone interpreters are available in 180 languages.

Unique Features:

- In addition to accepting phone calls, the new Day One Call Center is able to assist victims/survivors who choose to reach out via text or through a chat function on the website. This will further decrease barriers to accessing safety.
- Call Center staff have extensive experience in trauma-informed and victim-centered services and have completed over 75 hours of training on domestic violence, sexual violence, human trafficking, and general crime.
- Regardless of where a caller is located, the number to reach help is the same. The Call Center advocate will help determine the best resources and options for the caller.

To address the rising demand for commercial sex, [Men As Peacemakers](#) in Duluth has developed a public awareness campaign and educational resources called the [Don't Buy It Project](#). The Don't Buy It Project includes a [comprehensive toolkit of resources](#) to help individuals, groups, and communities to build understanding of the damage caused by commercial sexual exploitation and begin to shift attitudes and norms to decrease demand for commercial sex.

While Minnesota has made some great strides in ending commercial sex, what's still missing is a primary prevention strategy focused on reshaping the "normal" culture that allows commercial sexual exploitation to thrive. This requires strategic messaging, educational resources, and organizing focused predominantly on the conditions that make it acceptable for a majority of men to remain silent, if not actively participate in, commercial sexual exploitation.

Minnesota needs communities to rally around clear messages that degrading people and utilizing them as sexual objects is harmful and unacceptable. We need men who have never purchased people who are prostituted to talk with other men and boys in their community. We need community groups to actively work to reduce the normalization of CSE in their communities. It's time for communities to rally around clear messages and resources. **Don't Buy It: People are More Than Products; Men Are More Than Consumers.**
