Statement Against Hate Crimes

On Wednesday, October 24th, a white man shot and killed two African-American people, **Maurice Stallard (69)** and **Vickie Lee Jones (67)**, at a supermarket in Jefferson, Kentucky. He had first tried to enter a predominantly African-American church the week before.

On Friday, October 26th, a man was arrested and charged with a string of crimes in connection with homemade pipe bombs which he sent to former president Barack Obama, former secretary of state Hillary Clinton, and others who had been criticized by the Trump administration.

On Saturday, October 27th, a man shouting anti-Semitic slurs opened fire at the Tree of Life Synagogue in Pittsburgh, killing 11 people who were attending a baby naming ceremony and injuring 2 others. By stating their names, we remember and honor their lives.
