### **Equal Justice Works: Crime Victims Justice Corps Fellowship Program**

Equal Justice Works invites eligible organizations to apply to participate in the Crime Victims Justice Corps Fellowship Program, an initiative funded by the Office for Victims of Crime, to increase capacity and access to civil legal help for crime victims. The Crime Victims Justice Corps will mobilize 62 Fellows and 34 summer law students over a two-year Fellowship period, from June 2018 to May 2020. Fellows and law students will work at nonprofit organizations across the country, serving survivors of human trafficking, campus sexual assault, fraud and/or identity theft, hate crime, and immigrant victims.

### **Minnesota Department of Health: Safe Harbor Grant Awards Will Expand Capacity to Address Labor Trafficking**

The Minnesota Department of Health is pleased to announce grant awards to provide specialized services for labor trafficking victims ages 24 and under. The following agencies will help build state capacity to address labor trafficking in Minnesota.

- **Minnesota Southwest Crisis Center** – The Minnesota Southwest Crisis Center is located in Southwestern Minnesota and serves residents of Jackson, Cottonwood, Nobles, Rock, and Pipestone counties. They will provide group sessions, life skills training, case management and advocacy. 507-376-6624
- **The Advocates for Human Rights** – Based in Minneapolis, the Advocates for Human Rights will provide legal assistance for foreign nationals and training for attorneys to assist with labor trafficking. 612-341-3302
- **Standpoint** – Standpoint is an organization based in Minneapolis staffed with experienced lawyers and advocates. They will provide legal assistance to foreign nationals who have also experienced domestic or intimate partner violence, as well as training for attorneys statewide. 612-343-9842 or 800-313-2666
- **The Enitan Story** – The Enitan Story is a nonprofit dedicated to serving victims of human trafficking, and will provide case management, community outreach, and skill training. The Enitan story is based in Spring Lake Park. 763-273-6624

As part of the application, you can also make one-time resource requests. If there is some tool/resource that you need (e.g. resources on how to do staff evaluations), you can indicate that on the application. If you have a one-time resource request but are not interested in the full peer support program, you can send in the application with just your contact information and your resource request.

Applications will be reviewed and peer matches will be made by the coalition directors and each pair will be notified. All people who apply will be matched with another director. We anticipate having matches set up within two weeks of application.

In this webinar, Randy Lawrence will provide an overview of the various types of identity theft, including those involving medical information and false identification upon arrest. He will examine criminal motivations, tactics, and technology, and will provide specific recommendations for identity theft investigations. This webinar will serve as an introduction to identity theft investigation, and will be particularly valuable for law enforcement, systems based victim/witness advocates, and county prosecutors.

**Randy Lawrence: Cybercrime Expert, Retired**

Randy Lawrence is currently retired after 30 years in law enforcement. He was a commander in the San Diego County District Attorney's Office, chief of humane law enforcement for the San Diego Humane Society, and most recently was a lieutenant at San Diego State University. Randy is a cybercrime expert, and a trained computer forensic examiner. Specializing in identity theft, Randy has published multiple magazine articles and has taught courses on identity theft. Randy worked with the Internet Crimes against Children Task Force, a national network of law enforcement and prosecutorial agencies pursuing cases involving child abuse and exploitation via the internet. Prior to this he worked on the CATCH (Computer and Technology Crime High Tech Response Team) task force, a multi-agency effort dedicated to investigating internet crimes and advanced technology.

The first half of the day will be the official first meeting of the network, featuring a welcome from former Minnesota Attorney General of the State and State Senator Skip Humphrey. 
